 - Latches in closed and open position
 - Full extension ball bearing slides extend 14"
 - Telescopic rear supports fit all cabinets
 - Shelf area 17-1/2" wide by 14-5/8" deep
 - UL listed in the US and Canada

- Nylon roller slides extend 11-3/8"
- Occupies one rackspace
- Telescopic rear support mounts to any rack (rear rackrail required in steel racks)

Full-extension, ball-bearing slides shall extend 14". Shelf area shall be 17.5" W x 14.69" D. Heavy-duty quarter-turn, detented latch shall keep the shelf in its open or closed position. Maximum weight capacity shall be 50 lbs. SS shall be UL Listed in the US and Canada. Sliding shelf shall be GREENGUARD Indoor Air Quality Certified for Children and Schools. Sliding shelf shall be RoHS EU Directive 2002/95/EC compliant. Sliding shelf shall be manufactured by an ISO 9001 and ISO 14001 registered company. Sliding shelf shall be warranted to be free from defects in material or workmanship under normal use and conditions for a period of three years.




Sliding Shelves basic dimensions
